**THIS CONTRACT IS SPECIFICALLY WRITTEN FOR BOARDING WITH OPTION TO RELINQUISH BIRD FOR LONG-TERM PERMANENT CARE. BIRD WILL BE ACCEPTED IN THE SANCTUARY WITH PROPER VETERINARY RECORDS, HAVE RECENTLY HAD A VETERINARY PHYSICAL, BEEN TESTED FOR PDD, BFD, CHLAMYDIA, ASPERGILLUS, POLYOMA AND PACHECO OR IF NO RECORDS ARE AVAILABLE A FEE MUST ACCOMPANY THE BIRD IN ORDER TO BE ADMITTED TO UNDER MY WING FOR BOARDING OR PERMANET PLACEMENT. FEE FOR VETERINARY CAE IS \$900**

**BIRD ENTERING OUR SANCTUARY WILL BE IN QUARANTINE FOR A MINIMAL OF 30 DAYS UNLESS APPROVED BY VETERINARY TO FOR OTHER QUARANTINE PERIOD.**

Under My Wing shall board said bird for a maximum time of three weeks from boarding date, if longer period is needed please be sure to check for room availability.

#### **Boarding Fees:**

Daily Rate is \$20.00 per bird per day for all sized birds

Weekly Rate is \$125.00 per bird per week for small/med birds.

Weekly Rate is \$250 per bird per week for large/extra large birds.

Please add \$3 additional fee if medication is to be administered (\$3 per day).

Boarding Fee must be paid in full and in advance. Under My Wing reserves the right to hold your credit card account on file until bird is picked up and will charge weekly if bird is left more than said time.

To redeem your bird from boarding, all fees and any incurred medical and/or other necessary (or requested) expenses must be paid before the bird will be released. Boarding with option to relinquish is limited up to 3 weeks from boarding date for birds that are to be relinquished and must be picked up at such time as scheduled above.

Client shall receive all veterinary and lab reports if any were done while bird was boarded with Under My Wing. Under My Wing will not be held responsible for injuries/loss.

Boarding with option to relinquish and retire bird for lifetime care is as follows:

Boarding fees shall not be applied to amount due to relinquish or from lifetime care.

**TO RETIRE BIRD FOR LONG-TERM PERMANENT CARE:**

**BIRD ENTERING OUR SANCTUARY WILL BE IN QUARANTINE FOR A MINIMAL OF 30 DAYS UNLESS APPROVED BY VETERINARY TO FOR OTHER QUARANTINE PERIOD.**

Please complete relinquished application below with the applicable sponsorship amount: a two-year payment of \$1,000 (small bird), \$1,500 (medium bird) and \$2,000 (large Bird) per year and provide Under My Wing with a scheduled and secure payment plan for additional years for the remainder of the life of the bird's life.

Client shall reserve the right to change this option and not retire the bird for long term lifetime care. In such case, client shall notify Under My Wing within the first fifteen days from boarding date in order to receive full refund of pre-paid lifetime care fees and the bird shall be returned to the client upon release of bird boarding period less boarding fees, veterinary and disease testing and any incurred medical and/or other necessary (or requested) expenses Under My Wing incurred while bird was under boarding agreement.

\_\_\_\_\_ I have read and accept above agreement as my option to retire my bird for long-term permanent care.

I am including payment for two years in the amount of \$ \_\_\_\_\_ per year and provide Under My Wing with scheduled payments and plan for additional years for the remainder of the life of the bird. I understand that this fee shall be returned to me shall I opt not to retire my bird and notify Under My Wing of such decision in writing within fifteen days from boarding date listed above.

I am in the understanding that upon my consent to retire my bird for long term permanent care Under My Wing will refund to me the amount of the boarding fee I have paid. Veterinary care will not be returned.
